#### **Power**

1. This direction is given by the *PRA* under section 138A of *FSMA*.

#### **Duration**

- 2.1 This direction takes effect on 1 August 2023.
- 2.2 This direction applies in respect of specified *remuneration* awarded to *material risk takers* employed by the entities listed in Annex 2 on or after the date specified in paragraph 2.1 and on or before 31 May 2024.
- 2.3 In this direction "specified *remuneration*" means variable *remuneration* that consists of *shares* provided for under a share incentive plan with an initial market value at the date of issuance that does not exceed £1,500.
- 2.4 Unless otherwise stated, any italicised expression used in this Direction has the same meaning as given in the Part of the PRA Rulebook to which it relates.

#### **Rules waived**

3. The *PRA* directs that the rules listed below are waived for the *firms* in relation to specified *remuneration*.
