Data for *Bankstats (Monetary and Financial Statistics)* are released on the internet on these dates, including effective interest rates, Divisia money, UK central government and other public sector foreign currency debt, Bank of England foreign currency liabilities, M3 (estimate of EMU aggregate for the UK), liquid assets outside M4, monetary financial institutions' gross and consolidated balance sheets including sectoral breakdown and contributions, MFIs in Jersey, Guernsey and Isle of Man balance sheet, quoted interest rates (Final).

1. Please note that from July 2017 the schedule of this release will change slightly. Publication will now be five working days after the last Wednesday of the month rather than the first Wednesday of the following month. This will only change the timing of the release where bank holidays fall between these Wednesdays.

2. Please note that these dates have changed from the previous calendar as a consequence of the timing changes outlined above.
