25th January 1906.

The Committee had before them a letter *dated 17<sup>th</sup> inst.*  
from Messrs Freshfield suggesting that a petition  
should be lodged, as a matter of precaution, against  
the Hammersmith, City and North East London Tube  
Railway Bill, from the plans of which it appeared  
that the proposed Railway was to pass beneath both  
the Western and the Law Courts Branches of the  
Bank; and it was agreed to concur in the suggestion,  
and to recommend to the Court that the Common Seal  
of the Bank should be affixed to such petition.
