#### How we use your information

##### Information we collect

By this form the Bank of England ('we' or the 'Bank') collects personal data about you. This information includes your name and professional contact details.

##### Why we need your personal data

We collect your personal data to process your schools' entry into the Bank Camera Action competition as part of our outreach activities. The processing of your data is therefore necessary for the performance of a task carried out in the public interest.

##### What we do with your personal data

We use the information to contact you about your competition entry and to request clarification or further details about your film if required. We may also use your contact information to send you information about educational materials, further information regarding competitions and resources that may be of interest to your school in the future. If you do not wish to receive this information please contact us at [education.programme@bankofengland.co.uk](mailto:education.programme@bankofengland.co.uk). We keep your data for 3 years from the last interaction with you.

##### Your rights

You have a number of rights under data protection laws (for example, you have the right to ask us for a copy of the personal data the Bank holds about you. You can ask us to change how we process or deal with your personal data, and you may also have the right in some circumstances to have your personal data amended or deleted.
