

Conditioning assumptions, MPC key judgements, and indicative projections May 2016

This document contains five tables of projections:

- Table 1 shows the conditioning assumptions used for the MPC's projections;
- Table 2 shows the MPC's mean projections for GDP, CPI inflation and LFS unemployment;
- Table 3 shows a summary of the headline forecast variables;
- Table 4 shows profiles that illustrate the MPC's key judgements as described in Section 5; and
- Table 5 shows indicative projections produced for the MPC by Bank staff to be consistent with the MPC's modal projections for GDP, inflation and unemployment.

The projections in Tables 2, 3, 4 and 5 have been conditioned on the paths shown in Table 1, and the assumption that the stock of purchased assets financed by the issuance of central bank reserves remains at £375 billion throughout the forecast period.

The mapping from the key judgements to individual variables is not precise, but the profiles in the table should be viewed as broadly consistent with the MPC's key judgements.
- (b) Figures show calendar-year growth rates unless otherwise stated. Figures in parentheses show the corresponding projections in the February 2016 *Inflation Report*. Calculations for back data based on ONS data are shown using ONS series identifiers.
- (c) Chained-volume measure. Constructed using real GDP growth rates of 146 countries weighted according to their shares in UK exports.
- (d) Chained-volume measure. Constructed using real GDP growth rates of 147 countries weighted according to their shares in world GDP using the IMF's purchasing power parity (PPP) weights.
