Bank of England Euro Bills

The Bank of England today announced the issue of h1,000 million nominal of Bank of England Euro Bills, for auction on a bid-yield basis on Tuesday, 10 July 2001, in the following maturities:

€200 million for maturity on 16 August 2001,

€500 million for maturity on 11 October 2001 and

€300 million for maturity on 17 January 2002.

An additional €50 million nominal of six-month Bills, maturing on 17 January 2002, will be allotted directly to the Bank of England. A copy of the auction notice published by the Bank is attached.
