## **Bank of England Euro Bills**

The Bank of England today announced the issue of €900 million nominal of Bank of England Euro Bills, for auction on a bid-yield basis on Tuesday, 8 March 2005, in the following maturities:

€600 million for maturity on 16 June 2005 and

€300 million for maturity on 15 September 2005.

An additional €50 million nominal of six-month Bills, maturing on 15 September 2005, will be allotted directly to the Bank of England. A copy of the auction notice published by the Bank is attached.
