### Capital issuance: October 2015

Gross capital issuance by UK residents was £35.1 billion in October 2015, £10.2 billion greater than in September.


Net capital issuance by UK residents was -£1.0 billion in October 2015, £4.4 billion less than in September.



#### **Technical notes**

- 2 The sectoral split of capital issuance by UK residents includes an 'other' sector which comprises local government and not for profit institutions serving household (NPISH).
- 3 When banks issue or buy back shares, this is generally done through a holding company which, for statistical purposes is classified as an Other Financial Corporation (OFC).
