Gross capital issuance by UK residents was £26 billion in July 2016, £3 billion greater than in June.

Net capital issuance by UK residents was -£4.8 billion in July 2016, £0.5 billion less than in June.



#### **Technical notes**

- 2 The sectoral split of capital issuance by UK residents includes an 'other' sector which comprises local government and not for profit institutions serving household (NPISH).
- When banks issue or buy back shares, this is generally done through a holding company which, for statistical purposes is classified as an Other Financial Corporation (OFC).
